VISITING ARTIST AGREEMENT
Fri., Sat., Sun. April 9,10,11, 2010

Submission of the Visiting Artist Agreement does not guarantee space as artwork must be reviewed and accepted by the members of the Open Studio Jury. Both checks will be returned to those artists who are not accepted. All artists who participated last year and received a letter of invitation have already been accepted. Their work does not have to be reviewed again. Participation fee is **\$90.00 due by Thursday, January 7, 2010**. A **damage deposit in the amount of \$25** is also required. This will be returned to all visiting artists who comply with the information stated below. Please make out **2 checks**. Checks should be payable to **Fountain Street Studios** and mailed to the above address **Attention: Bill Horsman, Treasurer**

Hallway gallery space is limited. Requests for specific spaces will be considered but not guaranteed. Once spaces are designated artists are expected to remain in that space throughout the weekend. General lighting is available in the hallway galleries. Any specific lighting is the responsibility of the artist (you may bring additional lighting and extension cords).

Space will be assigned in March. Once assigned, if you would like to view the space, an appointment can be coordinated.

Please note that all reasonable precautions will be taken to secure the gallery space and artwork.
The artwork will not be insured and all artists participate at their own risk.

Set-Up:

Please advise **Sorin Bica (don.bicaso@verison.net)** which day you will set up your work. **Friday**, (preferred) April 9, 3:00pm – 6:00 pm, or Saturday, April 10 between 8:00 am & 11:00am.
All spaces must be fully set up by 11 am Sat.

Visiting Artist Responsibilities:

1. The artist or a representative will be on-site Fri. from 6:00 to 9:00 and Sat. & Sun. from 11:00 am to 5:00 pm during both days of the event. Early breakdown will result in forfeit of damage deposit. If you are unable to participate on Friday OR at the last minute, please notify **Bill Horsman (bill@billhorsman.com)**.
2. At the close of the event, remove rubbish, repair holes in walls, etc. Spackle and touch up paint will be provided. The damage deposit check of \$25.00 will be returned to visiting artists who comply. The space must be returned to its original condition; otherwise the check will be deposited by FSS.
